

**ORDINANCE NO. 158**

**AN ORDINANCE AMENDING ORDINANCE NO. 107  
AND TO DECLARE AN EMERGENCY AND FOR OTHER PURPOSES**

WHEREAS, the City Council of the City of Goshen adopted Ordinance 107 on January 14, 2014, and thereby established regulations regarding outdoor lighting within the City of Goshen; and

WHEREAS, the City Council of the City of Goshen deems it advisable to amend the regulations regarding outdoor lighting within the City of Goshen.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF GOSHEN, ARKANSAS:

SECTION 1. That subsection (A) to Section 5 of Ordinance 107 shall be deleted and following language substituted:

(A) Outdoor lighting must use a full cutoff fixture and shall be hooded, shielded, and aimed downward. Outdoor LED lights shall have a correlated color temperature less than or equal to 3000 degrees Kelvin and shall be of the color amber. If using CFLs or incandescent lighting, including halogen, yellow outdoor lights shall be installed. Examples of acceptable and unacceptable light pollution control shielding and hooding are shown in Exhibit "A," attached herein. Awnings, canopies, roof structures and other opaque surfaces that are designed to shield the direct horizontal surface of the light source and direct light downward toward the building or other opaque surface may also be considered for compliance with this requirement.

SECTION 2. That the following subsections (G), (H) and (I) be added to the end of Section 5 of Ordinance 107:

(G) Motion sensors or timers shall be installed on outdoor lighting to extinguish when not needed.

(H) Sign illumination is restricted to eleven hundred (1,100) lumens or less to each side of the sign.

(I) Any developer submitting a lighting plan shall include the model number(s) of all fixtures to be used.

SECTION 3. EXHIBIT

The illustrations that were intended to be attached to Ordinance 107 were not. They are

attached hereto as Exhibit A.

**SECTION 4. REPEALER**

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

**SECTION 5. EMERGENCY CLAUSE:** The regulations concerning outdoor lighting require some clarification, which is needed immediately. It is hereby declared that based upon the conditions set forth herein, an emergency exists and this Ordinance, being necessary for the immediate protection of the health, safety, and welfare of the citizens of Goshen, Arkansas, shall be in effect immediately upon its passage, approval, and publication.

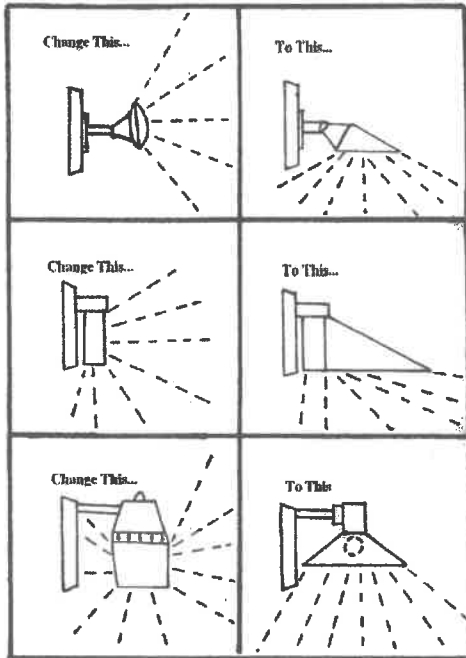

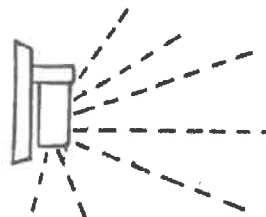

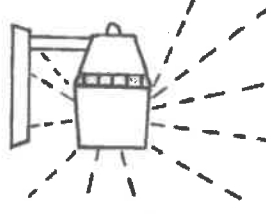
**MODIFYING EXISTING FIXTURES**



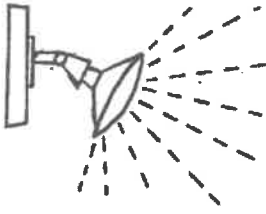

Typical "Wall Pack Fixture"

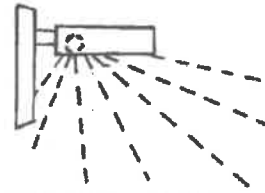


Typical "Barn Light"

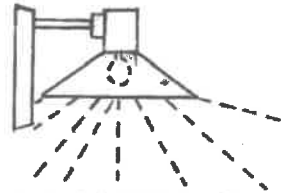


Area Flood Light

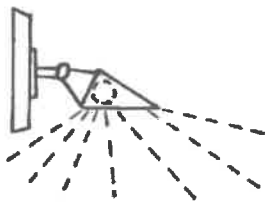

Typical "Shoe Box Fixture"

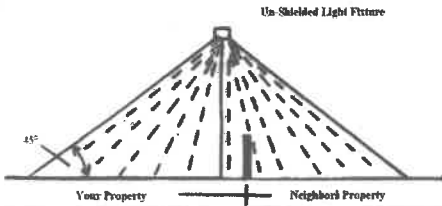


Opaque Reflector (lamp inside)
