

ORDINANCE NO. 228

**AN ORDINANCE AMENDING THE STANDARD OPERATING
PROCEDURE MANUAL WHICH WAS ADOPTED BY
ORDINANCE NO. 189 AND AS AMENDED BY
ORDINANCE NO. 195**

WHEREAS, the City Council of Goshen has previously adopted Ordinance No. 189, which adopted the revised Standard Operating Procedure Manual, and adopted Ordinance No. 195 which amended certain provision of the Standard Operating Procedure Manual; and

WHEREAS, the City Council of Goshen now desires to amend certain additional provisions in the Standard Operating Procedure Manual; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF GOSHEN, ARKANSAS:

SECTION 1. That section II of Section 31: Grooming and Uniforms shall be amended by striking the words "medical light duty" from said section.

SECTION 2. That section IV(D) of Section 31: Grooming and Uniforms shall be deleted in its entirety.

SECTION 3. That section V(C)(iii) of Section 72: Vehicle Pursuit & Emergency Vehicle Operation shall be deleted in its entirety.

SECTION 4. That section III(C) of Section 73: Vehicle Use – Take Home Vehicle shall be amended by striking the words "light-duty or" from said section.

SECTION 5. That section III(D)(j) of Section 73: Vehicle Use – Take Home Vehicle shall be amended to read as follows: "Officers shall not park their assigned take-home vehicle at any commercial, public, or private location for compensation, unless approved by the Chief of Police."

SECTION 6. That section III(D)(m) of Section 73: Vehicle Use – Take Home Vehicle shall be amended to read as follows: "Officers may not use the vehicle to conduct personal business within Goshen City limits, unless approved by the Chief of Police."

SECTION 7. EMERGENCY CLAUSE: It is declared that based on the conditions set forth herein, an emergency exists and this Ordinance, being necessary for the immediate protection of the health, safety, and welfare of the citizens of Goshen, Arkansas, shall be in effect immediately upon its passage, approval, and publication.


